**1. CALL TO ORDER**

Don Kent noted the established quorum and called the meeting to order at 3:00 p.m.

**2. APPROVAL OF MINUTES**

The January 28, 2021 meeting minutes were reviewed and approved.

**MOTION: Theresia Trevino moved to approve.**

**Matt Jennings seconded.**

**All were in favor. The motion approved unanimously.**

### **3. MONTHLY DISCLOSURE REPORT ON INVESTMENT PORTFOLIO**

The TPIF market value balance ending March 31, 2021 was \$9,083,152,137, down from \$9,623,955,692 on December 31, 2020. The yield on March 31, 2021 was .31%, down from .35% on December 31, 2020. The drop in yield was caused by the continued drop in short-term investment yields. As an example, 90 day and shorter T-bill yields ended the quarter at the shocking level of .01%. The Federal Reserve has consistently stated that they have no intention of raising the Fed Funds rate in the near future and as maturities of our higher yielding investments made in prior years roll off, we are forced to reinvest at these painful current market rates.

One promising change in the markets to note though is the rise in the rates of 4 to 5 year treasuries, which we have been able to take advantage of. The 5 year ended the quarter at .90%, up from .30% at the end of 2020. This is due to recent inflation indicators beginning to heat up. If inflation does indeed continue to rise, the Fed will eventually be forced to raise rates. As stated in our previous reports, we continue to invest the Pool in an ultra-conservative, ultra-liquid manner with safety of principal being our number one goal.

### **4. INVESTMENT REPORTS OF FUNDS OUTSIDE THE COUNTY TREASURY**

**CORAL:** Giovane Pizano stated that there were no significant changes.

**LAND SECURED DISTRICTS:** Stephanie Persi reported no changes.

**SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY:** Imelda Delos Santos reported that there was an increase of \$12 million in the portfolio from the last report due to deposits for debt service. Otherwise, no significant changes.

**HOUSING AUTHORITY SUCCESSOR AGENCY:** No update given.

**PENSION OBLIGATION BONDS:** Imelda reported that there was a big decrease from \$80 million last quarter down to \$5 million this quarter due to payment of principal and interest debt service in February. Otherwise, no significant changes.

**RIVERSIDE PUBLIC FINANCING AUTHORITY:** Imelda reported no significant changes.

**INFRASTRUCTURE FINANCING AUTHORITY:** Imelda reported no significant changes.

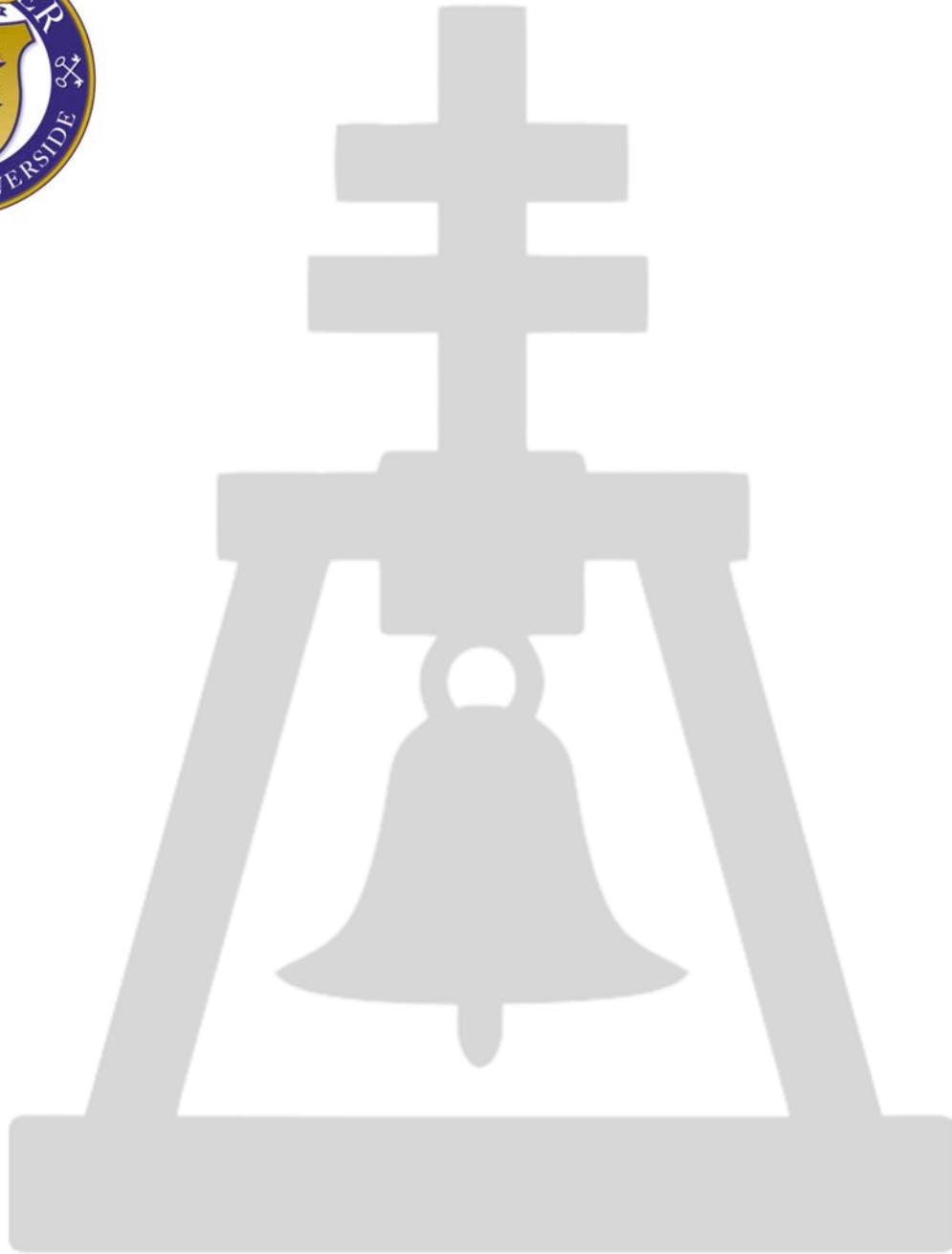

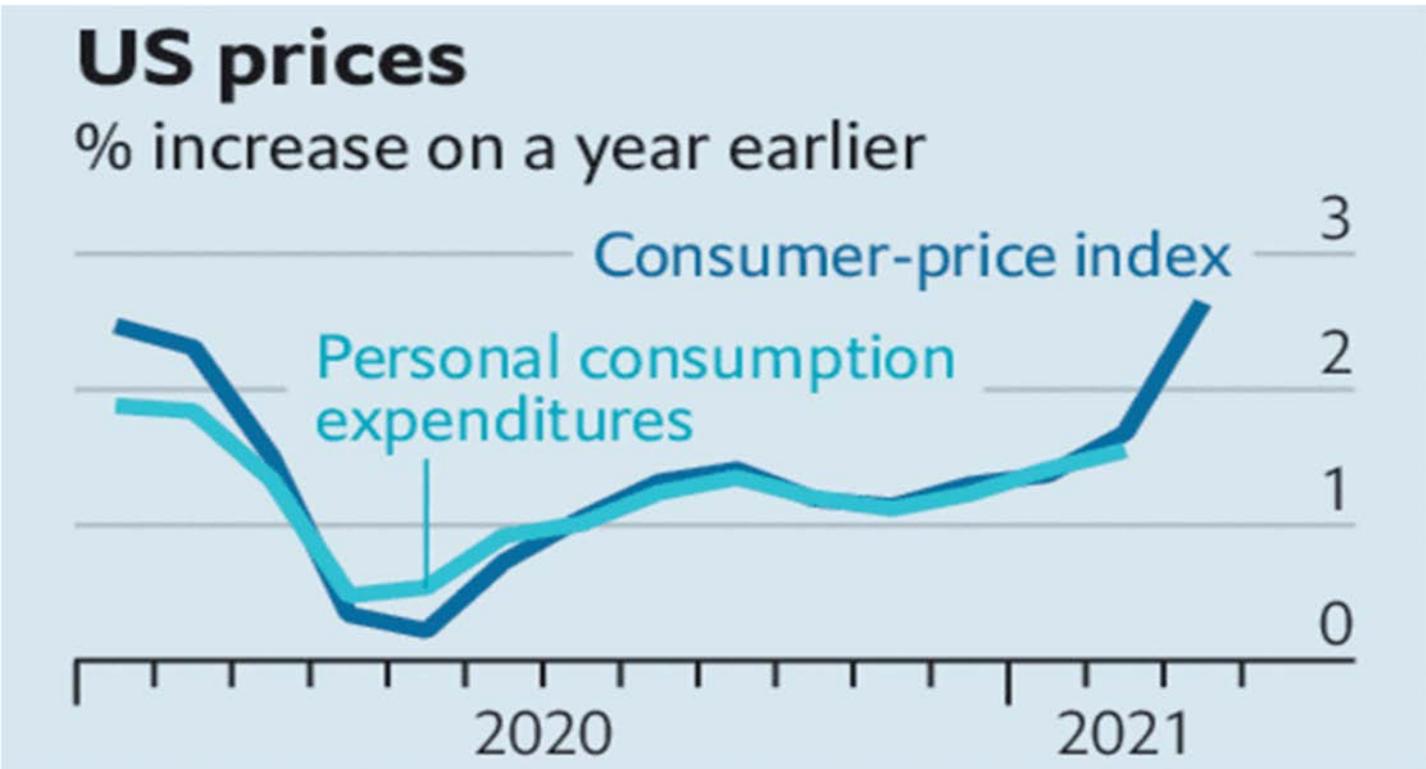

# Treasurer-Tax Collector's Pooled Investment Fund

## Monthly Commentary

### Consumers Go Out and Spend

Images of NASA engineers celebrating Mars Helicopter Ingenuity's historic first powered controlled flight on another planet, embodied the mood behind the surging confidence of consumers in April. Optimism marked a sunny contrast from the dark outlook of last April. The effectiveness of the COVID-19 vaccine distribution and economic recovery propelled consumers, armed with stimulus monies, to go out and buy. However, April was not all good news. The rising COVID variant cases overseas was cited as a reason for the bond market yield decline. Despite these declines, the Treasurer- Tax Collector Pooled Investment Fund (TPIF) hit an all-time high of \$10.3 billion on April 15.

April saw very strong economic releases as total retail sales surged 9.8%. The gain pushed the total level of sales a stunning 17% higher than it was before the pandemic. The ISM Services Index jumped to 63.7, signaling the fastest pace of expansion in the index's 24-year history. The blowout report is just the

latest data suggesting the full reopening boom is upon us. First quarter GDP came in at an impressive 6.4% increase, which was slightly lower than consensus but stronger than the previous level.

New home sales continued their strength with a headline grabbing 20.7% year over year increase. Builders are selling out new communities in days and are often having to limit sales, even after raising prices. Riverside County continues to see incredible home price gains with the most recent monthly report showing a 22.9% year over year gain in median single-family home prices!

CPI Ex food and energy remain below 2%, but signs of inflation gathered strength. The Producer Price Index report showed prices for domestically produced goods and services jumped 1.0% in March, sending the year-over-year rate to 4.2%, the fastest pace in nearly 10 years. PPI inflation has picked up since the start of the year, rising at a 12% annualized pace in the past three months.

At its April 28th meeting, the Federal

Reserve (Fed) repeated its commitment to keep rates at near-zero and buy at least \$120 billion of bonds per month for the foreseeable future. The Fed indicated that it considers current indications of inflation to be temporary, maintaining that because prices fell in 2020 at the outset of the pandemic, 2021 price increases are measuring from a low base.

Treasury markets were relatively stable for the month with little change in rates in the 0 to 3-year term, while 5- and 10-year Treasury notes declined slightly. The 5-year Treasury Note yield began the month at 0.90% and ended at 0.85%. The 3-month Treasury Bill yield dropped from 0.015% to 0.003% during the month. Stocks climbed with the Dow Jones Industrial Average beginning the month at 33,100 and ending at 33,900.

The primary objective of the Treasurer shall be to **safeguard the principal** of the funds under the Treasurer's control, meet the **liquidity needs** of the depositor, and to maximize a **return on the funds** within the given parameters.

The Treasurer-Tax Collector and the Capital Markets team are committed to maintaining the highest credit ratings. The Treasurer's Pooled Investment Fund is currently rated **Aaa-bf** by **Moody's Investor Service** and **AAAF/S1** by **Fitch Ratings**, two of the nation's most trusted bond credit rating services.

Since its inception, the Treasurer's Pooled Investment Fund has been in **full compliance** with the Treasurer's Statement of Investment Policy, which is more restrictive than California.

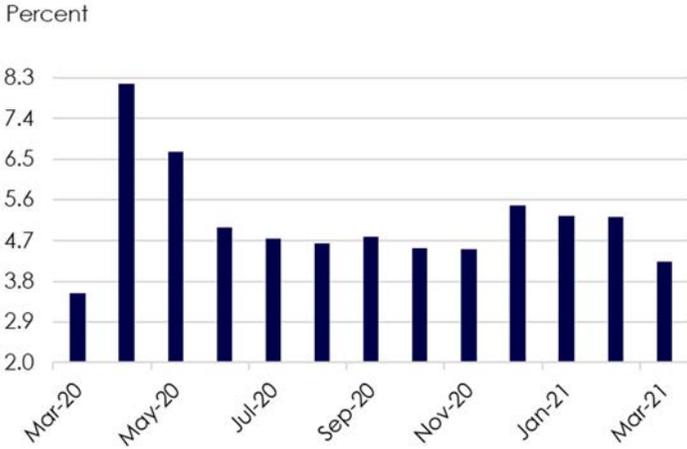

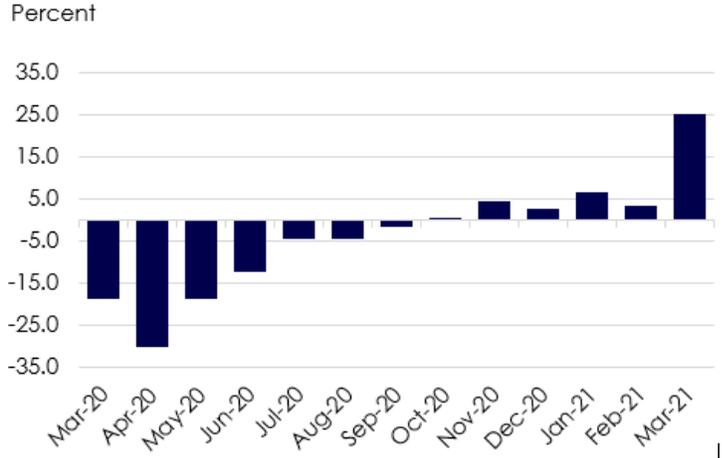

Private Sector Average Hourly Earnings Y/Y



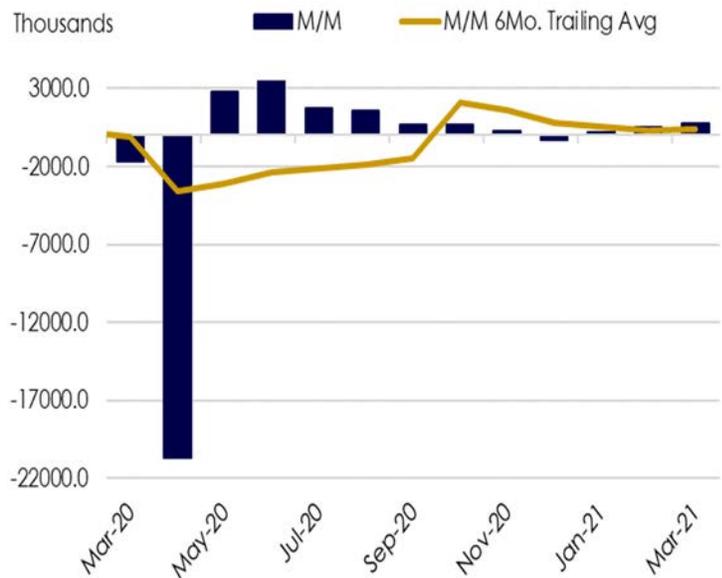
Durable Goods Percent Chg. Y/Y

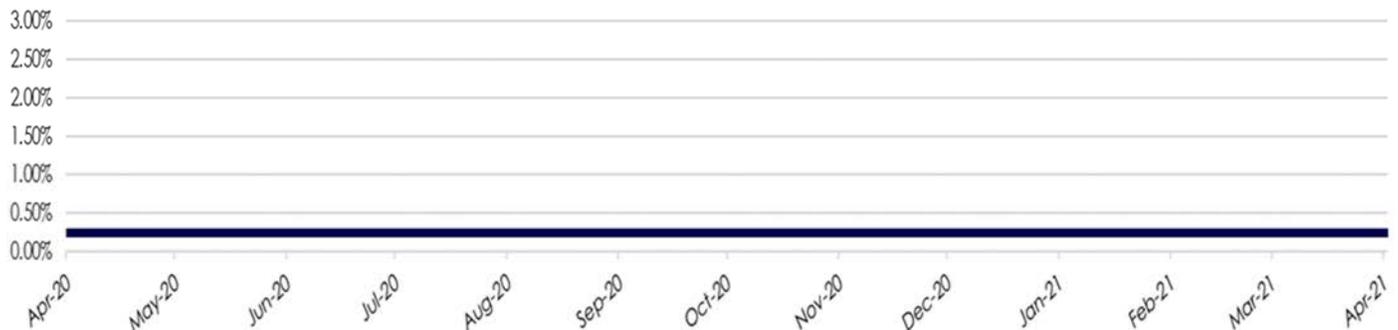

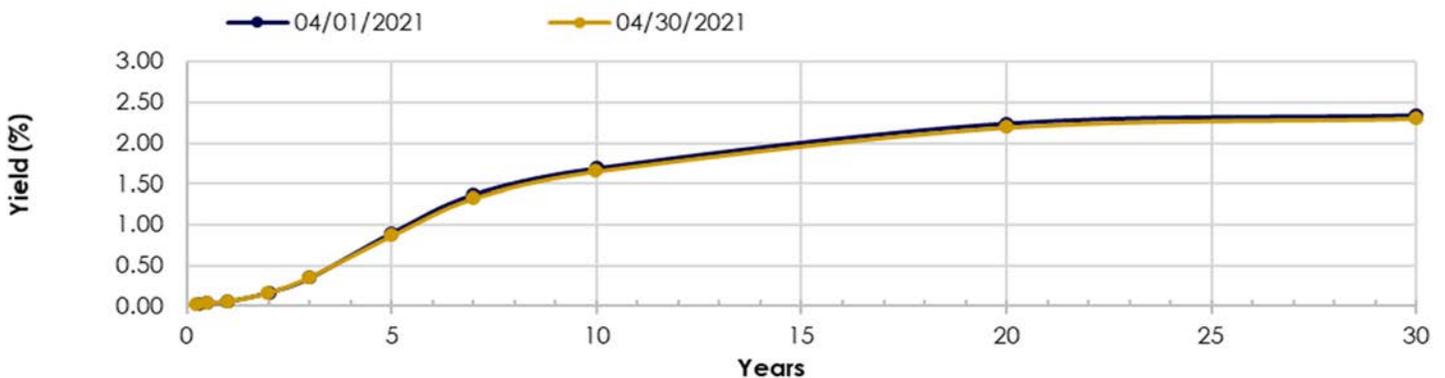
## Federal Open Market Committee Meeting

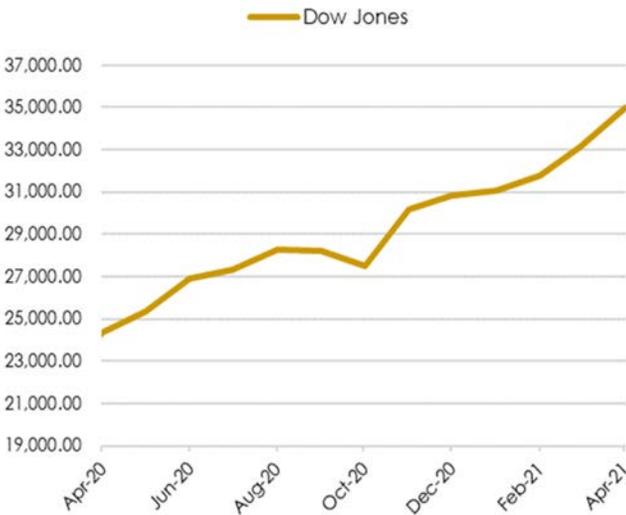
## U.S. Treasuries

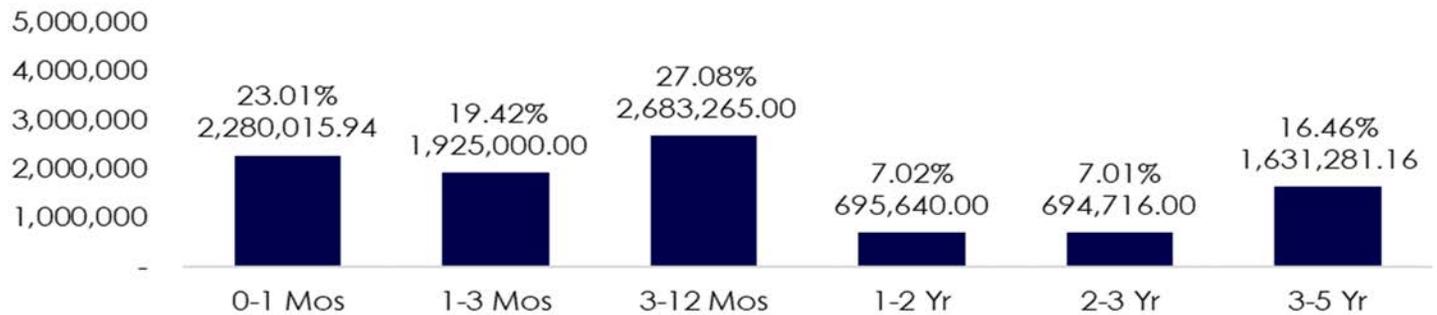

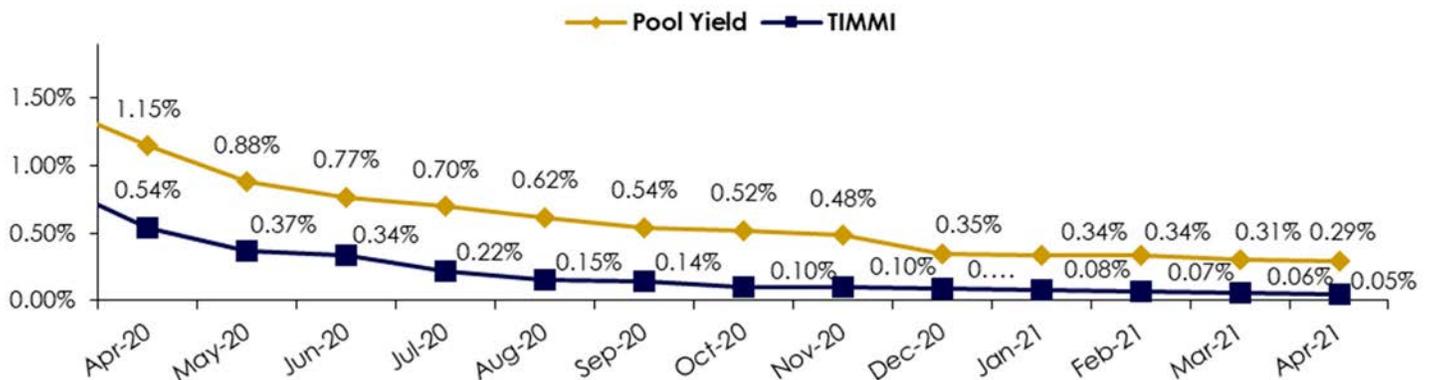
## Asset Maturity Distribution (Par Value, 000's)

The Treasurer's Pooled Investment Fund was in full compliance with the County of Riverside's Treasurer's Statement of Investment Policy. The County's Statement of Investment Policy is more restrictive than California Government Code 53646. The County's Investment Policy is reviewed annually by the County of Riverside's Oversight Committee and approved by the Board of Supervisors.

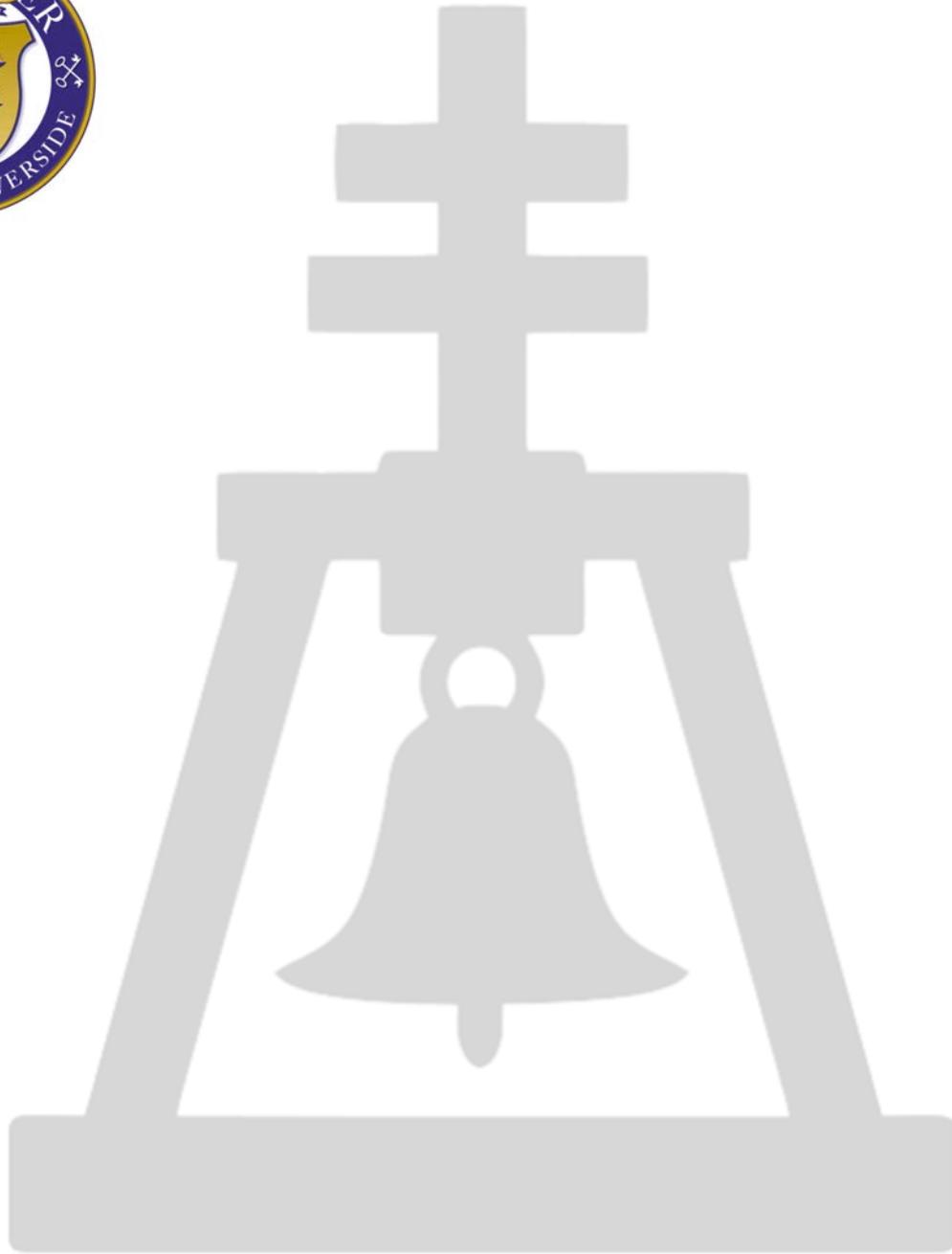

## Monthly Commentary

### Supply Woes "May" Drive Inflation Higher

Ransomware attacks, chip scarcity and used car prices shared the business headline space in May with the reopening. The positive effects of continued stimulus and the acceleration of the economy reopening, were somewhat offset by inflation concerns and some disappointing employment data. This led treasury yields to tip slightly lower in some maturities. The interest rate environment continues to frustrate savers who saw slightly negative rates in 90 days and in maturing securities. The Treasurer - Tax Collector's Pooled Investment Fund (TPIF) continues its focus on maximizing yield while prioritizing safety and liquidity.

Shortages in everything from lumber for home construction to microchips used in automobile production are driving inventories lower, which coupled with high demand, result in rising prices. CPI Ex Food and Energy YoY for April was reported as 3.0%. The number was higher than expected and also marked an increase from the previous level. Many observers attributed higher inflation readings to low

base effects from last year and temporary spending increases in three key areas: lodging away from home, airline fares, and used cars. Inflation concerns remained hotly debated, with the discussion focused on how transitory/permanent it is.

Lackluster April employment data bucked the recent positive trend in economic data. The manufacturing sector continued to improve with both Durable Goods Orders and Manufacturing Orders higher from the previous levels. Durable Goods Orders printed at 0.8%, an increase from the prior level of 0.5% and Factory Orders printed at 1.1%, an increase from the prior level of -0.8%. Other Indicators, like Retail Sales, were softer.

Initial Jobless numbers continued to trend lower, from a starting point of 490,000 to 406,000 at the end of the month. While a welcome sign of a continued recovery, Nonfarm payroll disappointed investors and confused forecasters. Change in Nonfarm payrolls was expected at 1 million, but came in at a disappointing 266,000, and the Unemploy-

ment Rate was expected at 5.8% but printed at 6.1%.

The absence of a Federal Reserve Open Market Committee (FOMC) meeting did not pause the discussion from economists and investors of what the FED's first step will be when it changes course on monetary policy. For many, the Fed's first step is for them to reduce the amount of bonds that they are buying monthly in the open market. Until recently, most predicted this to occur sometime in 2022, but as of late, talk is now shifting to a sooner date.

Treasury rates were little changed. The 1- month Treasury Bill began the month at a yield of -0.003% and ended at -0.008%. The 2-year Treasury Note began the month at 0.16% and ended at 0.14%. The 5-year Treasury Note began the month at 0.84% and ended the month at 0.80%.

Since its inception, the Treasurer's Pooled Investment Fund has been in **full compliance** with the Treasurer's Statement of Investment Policy, which is more restrictive than California.

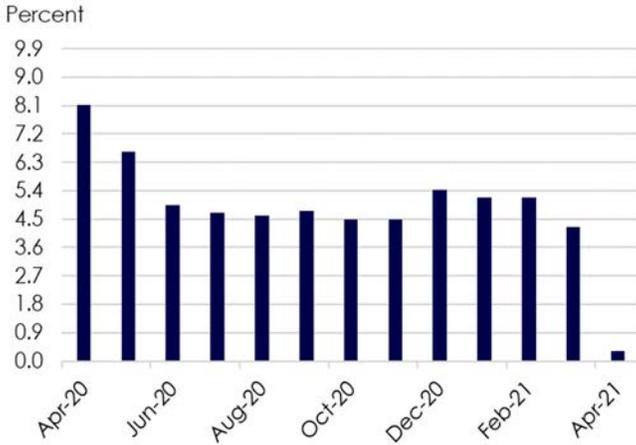

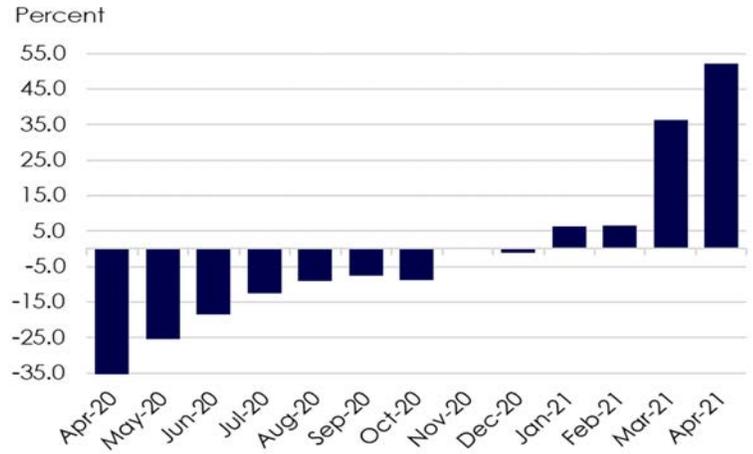

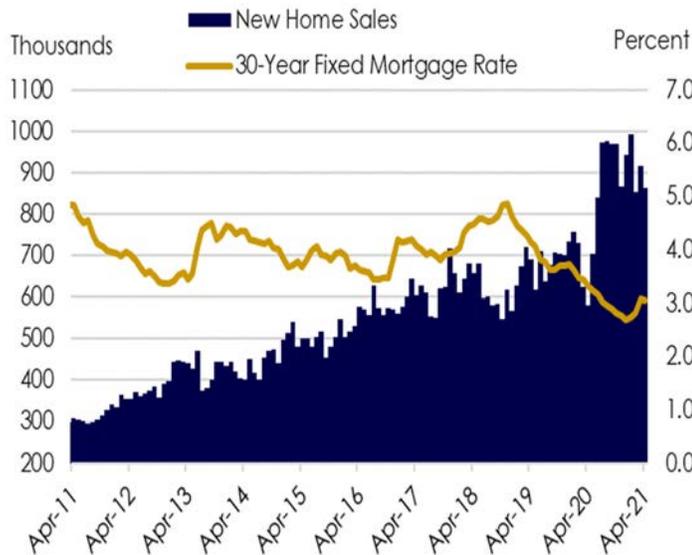
Private Sector Average Hourly Earnings Y/Y



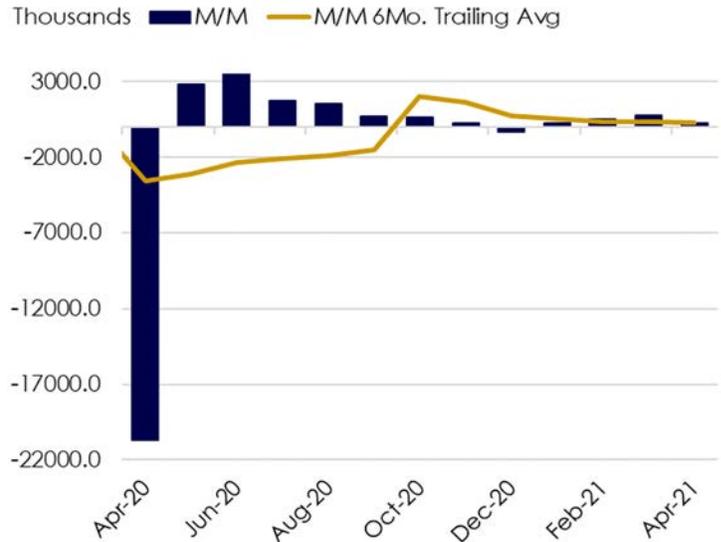
Durable Goods Percent Chg. Y/Y

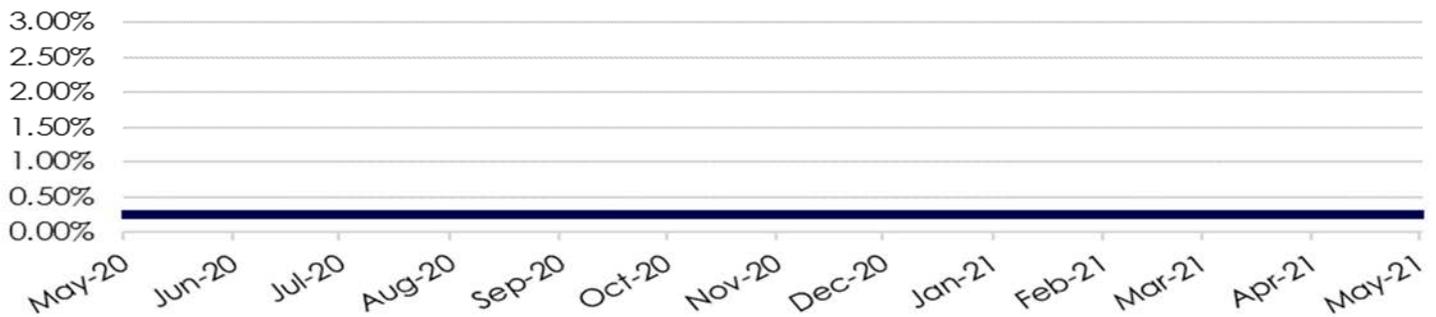

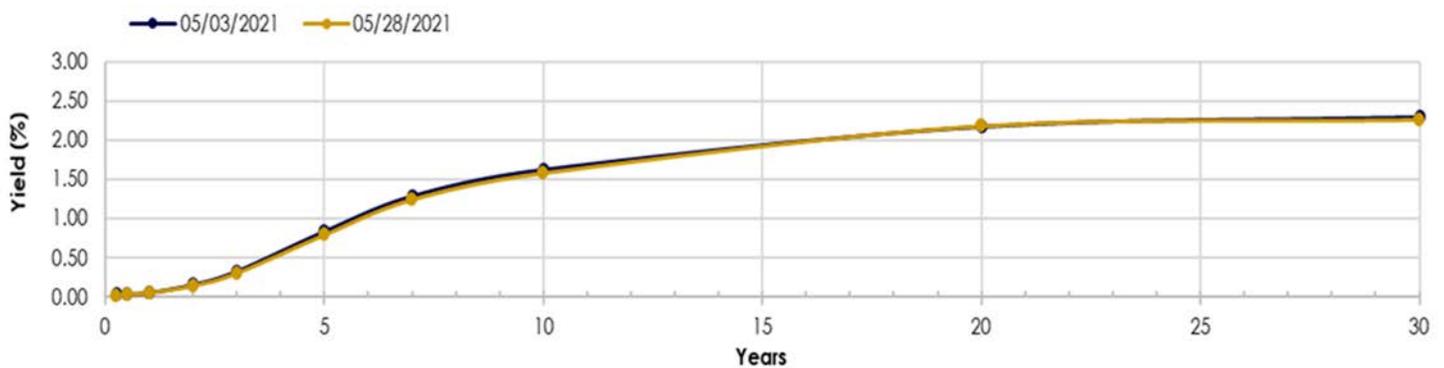
## Federal Open Market Committee Meeting

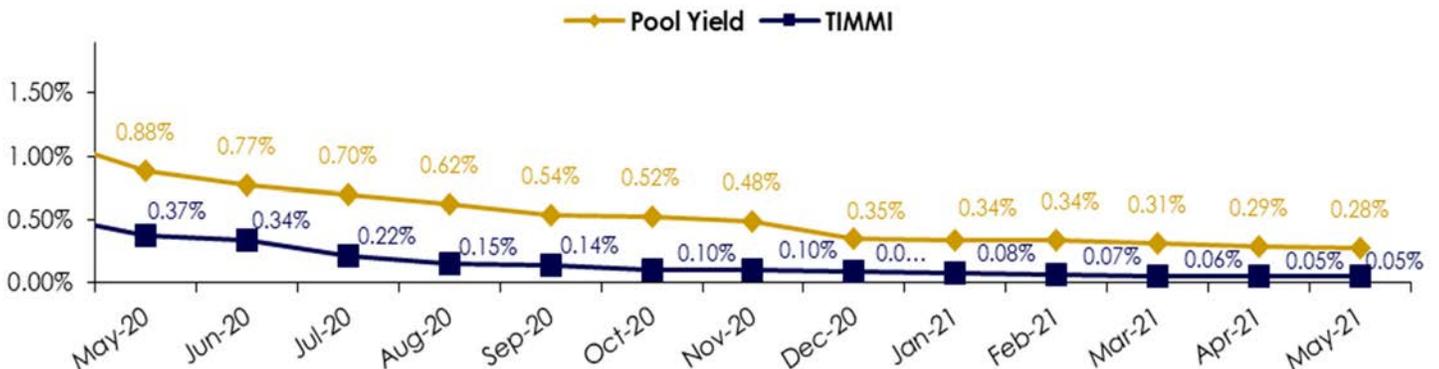
## Asset Maturity Distribution (Par Value, 000's)

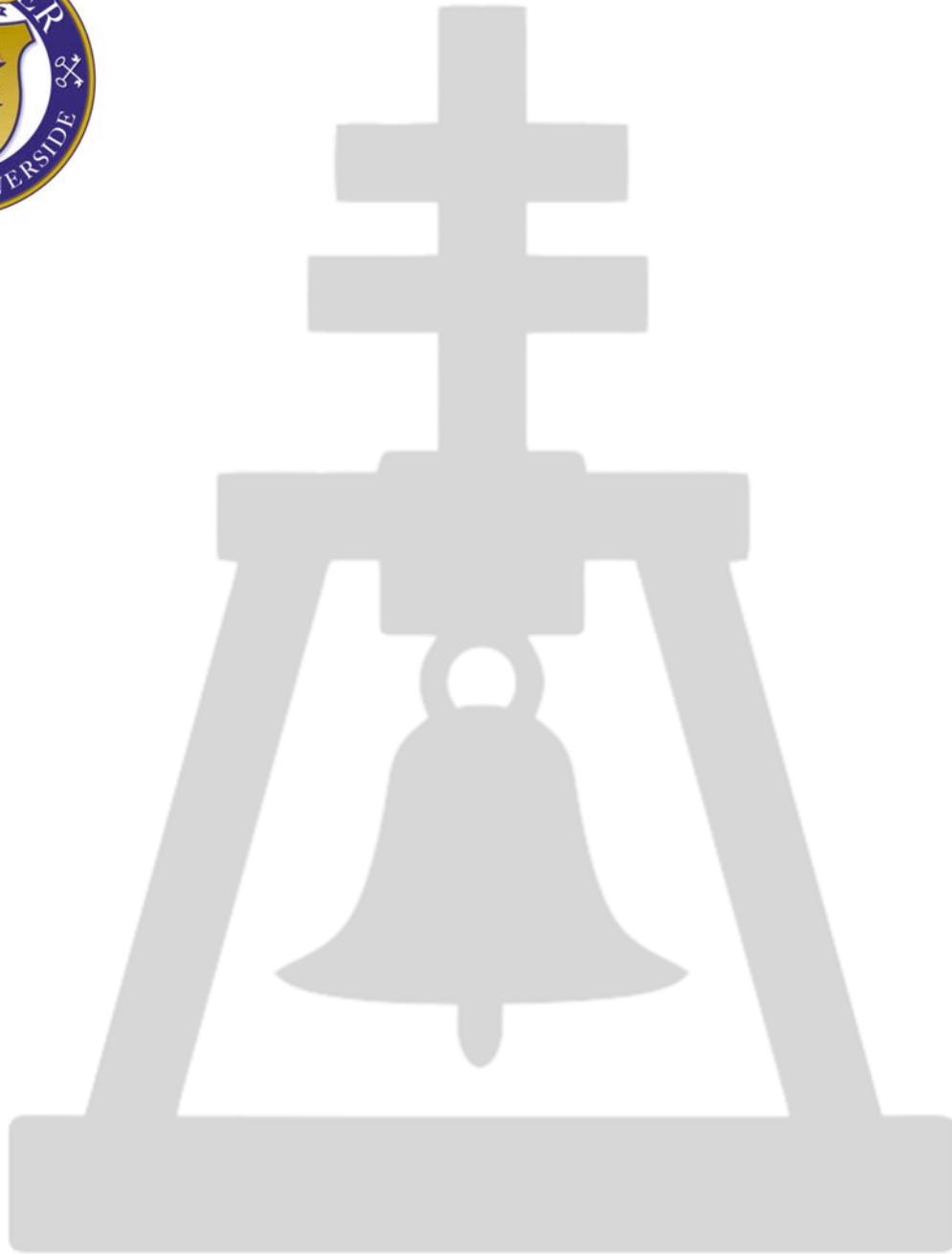

## Monthly Commentary

### Rates Inched up While Shortages Pinched Growth

Investors continued to focus on inflation and its impact on values and shortages, while monetary policy dominated market news in June. Economic data continued to point to strong growth, but material and labor shortages pinched the growth of the manufacturing sector and small businesses. Savers, and the Treasurer - Tax Collector's Pooled Investment Fund (TPIF) welcomed the slight change in FED policy, as it drove front end rates slightly higher.

The latest survey on Manufacturing PMI released in June, indicated another strong month of growth in May, registering 61.2 for the 12th consecutive month of expansion in the U.S. But while the top line number is impressive, and customer demand remains high, supply problems are driving goods prices higher and pinching growth. The 'prices paid' component of the most recent ISM services report reached the second highest on record.

In addition to supply chain shortages, employers are now finding it difficult to find new employees. In the latest National Federation of Independent Business (NFIB) report, nearly half of small business owners

had open positions they were unable to fill. The JOLTS Job Openings number best encapsulates the challenge. The June number printed at 9.28 Mn, which was stronger than the previous level of 8.1Mn. Companies are bumping up wages to try to attract employees.

Real estate continues to boom. Riverside County's housing market is a prime example, with the most recent data showing median single-family home prices up 22.6% year over year!

CPI Ex Food and Energy YoY increased to 3.8% from the previous level of 3.0% and was above market expectations. The FED's view of the increase in inflation is that it is transitory and continues to view inflation "anchored at its 2% average for the long-term".

The FED slightly adjusted its monetary policy and economic outlook, which caused short-term treasury rates to rise. On June 16, 2021 the FOMC increased the rate paid on excess reserve balances to 0.15% and the overnight reverse repurchase agreement rate to 0.05%. The FED's economic outlook also improved as re-

flected by the FED's Summary of Economic Projections (DOT PLOT) released on June 16, 2021.

The DOT PLOT view of the economy and interest rate outlook improved. The GDP consensus for 2021 increased from 6.5% to 7.0%. The number of FED voting members who see a rate hike in 2022 and 2023 increased significantly. Yet, the FOMC voted to keep FED Funds rate at the target range of 0.00% to 0.25%. The FOMC also made no changes to its monthly purchases of \$80 billion of agency mortgage-backed securities and \$40 billion of treasury securities.

In fixed income markets, the 3-month Treasury Bill yield increased from 0.0076% to 0.046% during the month; and the 5-Year Treasury Note increased from 0.80% to 0.89%. Stocks languished, with the Dow Jones Industrial Average beginning the month at 34,600 and ending at 34,600.

Since its inception, the Treasurer's Pooled Investment Fund has been in **full compliance** with the Treasurer's Statement of Investment Policy, which is more restrictive than California.

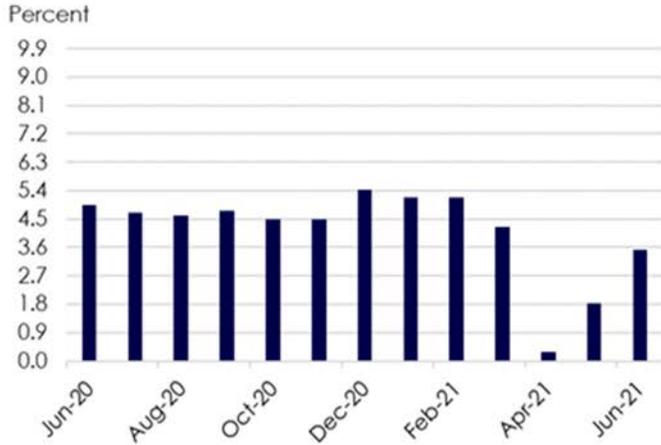

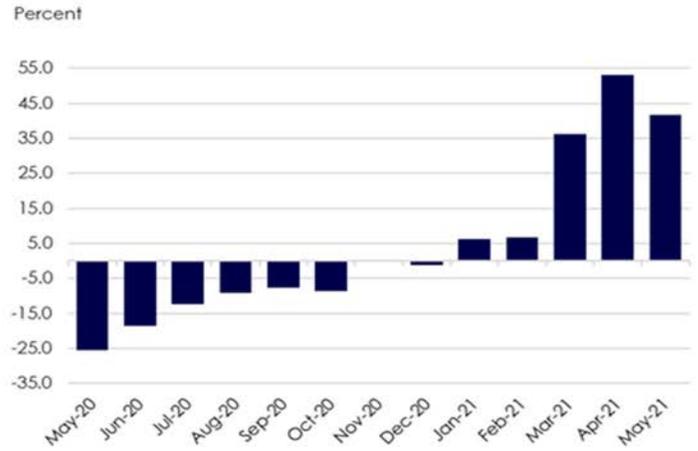

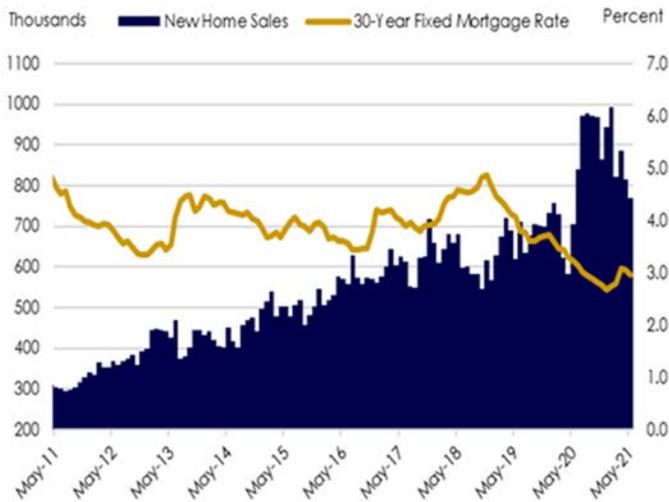
Private Sector Average Hourly Earnings Y/Y



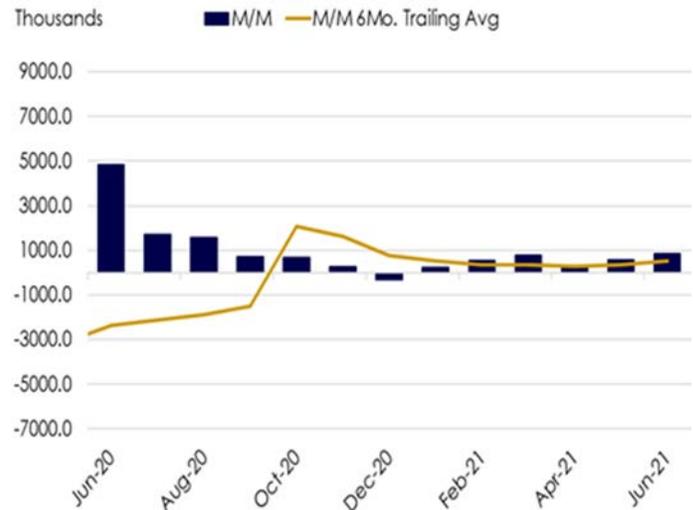
Durable Goods Percent Chg. Y/Y

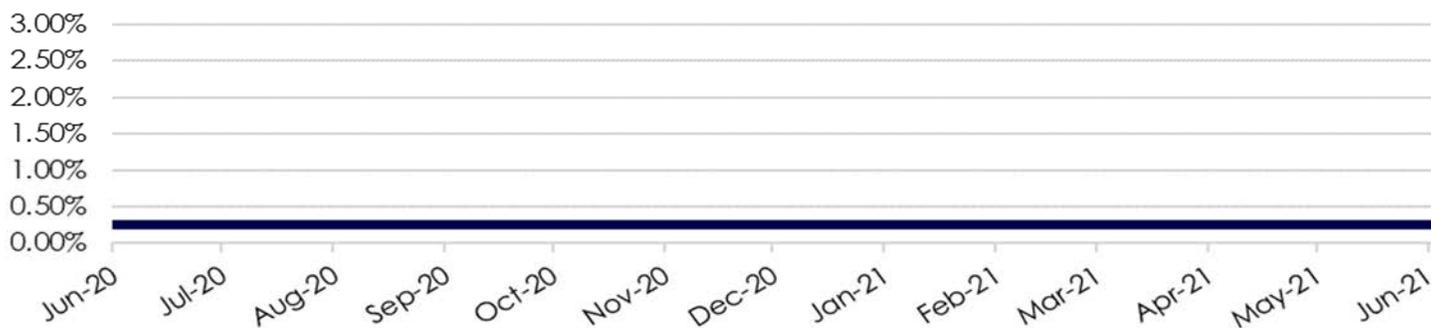

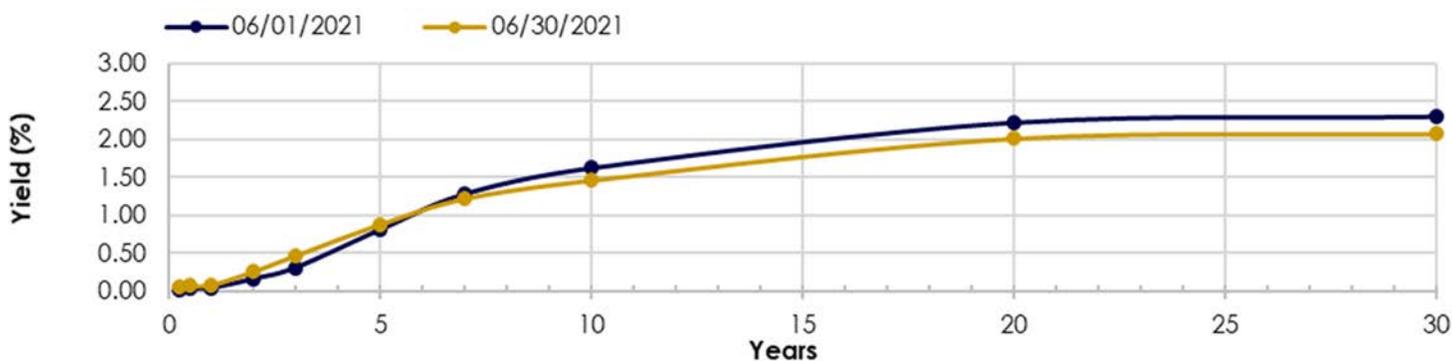
## Federal Open Market Committee Meeting

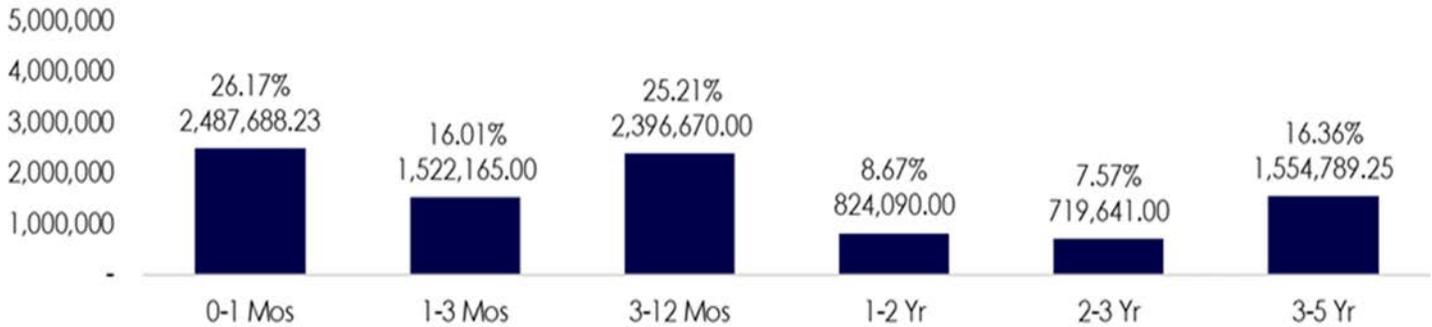

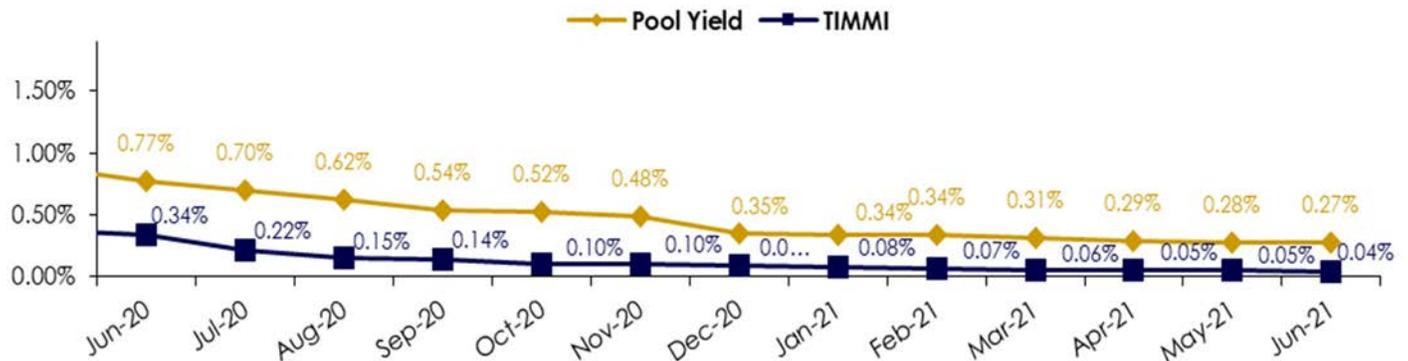
## Asset Maturity Distribution (Par Value, 000's)
